DEFERRED PAYMENT

Students who have been admitted to the Certificate Program, and are taking two courses per semester, may partially defer their tuition payment(s) as follows: By the first day of class, a deposit of \$250.00 is required. The balance of the tuition and registration fees is due by the fifth class session. Interest will be charged monthly at the rate of 1.5% on any unpaid balance. All outstanding balances must be paid in full by the fifth class session in order for the student to continue attending class, to receive credit for the class, or to register for future courses.
